- i) The registered Solar Energy Systems Providers under Sri Lanka Sustainable Energy Authority (SLSEA) for last Five years, who have successfully supplied, delivered, installed & commissioned having cumulative capacity of 05MW or more roof top Solar systems in Sri Lanka will be eligible to quote for this Bid.

- ii) The Bidder or Bidder's holding company should have a minimum of LKR 100.0 Million average annual turnover during the past three consecutive years (2020/2021, 2021/2022 and 2022/2023) or (2021, 2022 & 2023) and should be a profit-making entity with a positive net worth.
2. Bids will not be entertained from firms or persons who have been placed on the List of Defaulting Contractors of the Government of Sri Lanka or of the bank, or of any statutory Government Corporation or Board.
  3. Bidding will be conducted through National Competitive Bidding (NCB) Procedure.

The method of payment of non-refundable fee will be in the form of cash deposit which authorized by the undersigned.
  6. The documents annexed to "Invitation to Bid" must not be detached there from.

Perfected Bids should be accompanied by a **Bid Security for a sum of Rs.1,100,000.00 (Rupees One Million One Hundred Thousand Only)** in the form of bank guarantee provided in the Bidding document on-demand, unconditional and irrevocable issued only from a licensed commercial bank (other than Bank of Ceylon) acceptable to the Bank valid up to **21.08.2024**. Cash Deposit slip/Bank draft are also acceptable in lieu of Bank Guarantee. Cheques drawn by the Bidder will not be accepted as bid security.
