



INVITATION FOR BIDS

Supply, Delivery, Installation, Commissioning and Maintenance of JBoss EAP 8 Server Standard and Premium Licenses BID NO. PROC/P/2026/39

1. Sealed Bids are hereby invited for Supply, Delivery, Installation, Commissioning and Maintenance of JBoss EAP 8 Server Standard and Premium Licenses.
2. Bidders shall comply with the following minimum Eligibility criteria to be eligible for this bid.

i. General:

- a) The Bidder or any party of the Bidder shall not be on the list of Defaulting Contractors of the Government of Sri Lanka or of the Bank of Ceylon.
- b) The Bidder shall be an Authorized Direct Sales Partner and an Authorized Service Provider for the offered brand including support services. Software Manufacturer's confirmation is mandatory.

ii. Financial Capabilities:

The Bidder shall have an Average Annual minimum turnover of LKR 125 million for the minimum three (03) financial years (2024/25, 2023/24 and 2022/2023 or 2024, 2023 and 2022).

iii. Performances and Experiences of the Bidder and the Proposed Solution:

The Bidder shall have at least two implementation engineers who have been involved in similar deployments from the bid closing date.
