- 1 The Operations Manager, Uva Province, Badulla, invites sealed bids from eligible and qualified bidders for Proposed Relocation Work of Bank of Ceylon Keppetipola Branch at "Mangala", No 30, Nuwara Eliya road – South, Keppetipola as described below and estimated to cost of **Rs. 8.7 million plus taxes**.

Site is Bank of Ceylon Branch building at "Mangala", No 30, Nuwara Eliya road – South, Keppetipola.


Construction period is **30 calendar days**.

Scope of work;

- Proposed cladding work.
- Partitioning of Branch Manager & Pawning cubicles.
- Grill work of, Smart Zone.
- Gypsum partition for the Record, Stationary, & Storage rooms.
- Racks for the Record, Stationary & Storage rooms.
- Zebra Blinds for front Glass.
- Pantry cupboard wall unit.

- 2 Bidding will be conducted through National Competitive Bidding.
- 3 To be eligible for contract award, the successful bidder shall not have been blacklisted and shall meet the following requirements;
Registered with the Construction Industry Development Authority (CIDA) for grade **C8 or above** in the field of Building Construction.
- 4 Qualifications requirements to qualify for contract award include:
 - i. Experience in the construction of at least one contract of nature and complexity equivalent to the proposed work during the last 5 years;
 - ii. Technical staff resident at site – Technical Officer NCT or equal with 05 years' experience.

- 6 A complete set of Procurement document in English language may be purchased by the bidders on the submission of a written application to the Operations Manager, Uva Provincial Office, No-17, Hill Drive, Keppetipola road, Badulla **from 08.04.2026 until 21.04.2026 from 0900 hrs. to 1500 hrs.** upon payment of a nonrefundable fee of **Rs. 1500+tax(1815.38)**. The payment method of non-refundable fee will be in the form of cash deposit which authorized by the undersigned.

- 7 Sealed bids in duplicate shall be deposited in the tender box available at the **Office room of the Operations Manager**, or sent by registered post addressed to the Operations Manager, Uva Provincial Office of the above address to reach him on or before **14.00 hrs** on **22.04.2026**. Late bids will not be accepted and returned unopened. Bids will be opened immediately after closing in the presence of the Bidders' representatives who choose to attend.
- 8 Bids shall be valid up to **08/07/2026** (77 days from date of closing the bids).
- 9 All Bids shall be accompanied by a **Bid Security** in the form of Bank Guarantee (irrevocably unconditional and on demand) of Rupees Eighty Thousand (Rs. 80,000.00) obtained from a licensed commercial bank operating in Sri Lanka, other than Bank of Ceylon, which shall be valid up to **05/08/2026** Cash deposit slip / Bank draft for the same amount is also accepted in lieu of Bank Guarantee.
- 10 **PCA 3** Form should be accompanied with the Bid as per provision set out in the Public Contract Act No.03 of 1987 or any amendment thereof.
