#### Important Note:

- **Disable Antivirus Software:** Before installing the new update, temporarily disable your antivirus program. Some antivirus software may interfere with the installation process.
- **Restart Required:** After completing the update installation (whether via Online Update or using the Installer), restart your computer to apply the configuration changes.
- Update License Activation: If you are using an older version of UBS AIB (before v2022.4), download and run the Service Component Patcher to ensure your license activates correctly.
- Service Component Patcher: If you are already on Access UBS v2024.2 and did not get the OU notification, please go to the Download Page to download and run the patch file named Online Update Patcher. When you reopen the application, the OU notification will be prompted.

#### SST-02 Form Amendment 2025

We have updated the SST-02 reporting form to comply with Malaysia Customs' Amendment 2025 requirements. The enhanced form includes new fields for 8% service tax rates, bad debt relief reporting, and expanded exemption categories to ensure full regulatory compliance.

### **Release Contents**

#### MySST (Sales and Service Tax)

#### SST-02 Form Amendment 2025

The SST-02 form has been updated to align with Malaysia Customs' Amendment 2025. This update introduces significant changes to tax reporting requirements, including new tax rates, additional reporting fields, and enhanced categorization of taxable and exempted transactions.

#### **Key Enhancements:**

#### 1.8% Service Tax Rate Support

The system now supports the new 8% service tax rate for eligible services. Users can configure tax codes with the 8% rate and apply them to qualifying transactions. The SST-02 form includes a new Field 11d to separately report taxable services charged at the 8% rate.

#### 2. New Tax Method Mappings

To support the amended SST-02 form structure, new tax method mapping options have been added to the system. These mappings allow administrators to configure tax codes that automatically categorize transactions into the correct SST-02 form fields, ensuring accurate reporting and compliance.

#### 3. Bad Debt Relief Reporting (Field 13d)

A new manual input field (Field 13d) has been added to the SST-02 form to report bad debt relief claims. Tax reporting officers can now manually enter approved bad debt relief amounts as required by Malaysia Customs regulations.

#### 4. Enhanced Exemption Reporting

The SST-02 form now includes expanded exemption reporting capabilities:

- **Field 18c Sub-Categories:** The existing Field 18c has been split into three sub-fields (18c1, 18c2, 18c3) to provide detailed categorization of exempted taxable services.
- **Field 18d Non-Taxable Services:** A new field to report services that are not taxable by nature, allowing for clearer distinction between exempted and non-taxable transactions.
- Field 18e Legal Exemptions: A new field to report sales exempted under Subsection 35(3) and/or Section 61A of the Sales Tax Act 2018.

These enhancements ensure businesses can accurately report all categories of exemptions as required by the amended regulations.



#### Myelnvoice

#### Myelnvoice Enhancements

#### 1. Enhanced Contact Number Format Validation

The system now validates customer and supplier contact numbers in the elnvoicing configuration to comply with LHDN's formatting requirements. Phone numbers are automatically checked to ensure they do not contain special characters (such as dashes or spaces), except for the '+' symbol at the beginning for international numbers. This validation prevents submission errors and ensures smooth elnvoice processing.

#### 2. Currency Code Mapping Validation

A new validation has been added to the elnvoicing configuration to ensure currency code mappings are complete before submission. The system now blocks users from submitting elnvoices if the currency mapping is incomplete, preventing validation errors at the LHDN portal and reducing rejected submissions.

#### General

#### **Issue Resolutions**

Here is a summary of the concerns that have been addressed:

- Fixed an issue where PDF documents could not be generated for validated invoices with reference numbers containing slash characters, displaying "Error Loading Printer Driver (1958)".
- Fixed an issue where users were unable to open a second database when using Inventory & Billing in Classic View, requiring Task Manager to close the application.
- Fixed an issue where when transmitting transaction with SV08 tax code, error: "Tax amount should be equal to 0"
